SUBMISSION OF ADDITIONAL DOCUMENTS FOR RECIPROCAL REGISTRATION (KARNATAKA & TELANGANA APPLICANTS)

In view of increasing reports of fraudulent institutions and online-based nursing courses from the states of Karnataka and Telangana, it has been decided to implement stricter verification measures for all applicants seeking reciprocal registration from these states.

All applicants applying for reciprocal registration from Karnataka and Telangana must submit the following additional documents along with their reciprocal registration application:

A. Mandatory Additional Documents

1. Clinical Posting Certificate

- Issued by the concerned hospital
- Must clearly mention the area-wise clinical posting and total hours completed during training

2. Class Attendance Record (Transcript Form)

- Official transcript showing theory and practical attendance

3. Affiliation Certificate of the Institute with the State Nursing Council

4. Affiliation Details of the Institute with the Indian Nursing Council

B. General Documents to be Submitted (Duly Attested True Copies)

Application forms will be accepted only if enclosed with the following documents:

- Diploma/Degree Certificate of B.Sc. Nursing / GNM / ANM
- Mark Sheet of B.Sc. Nursing / GNM / ANM Course
- Registration Certificate (B.Sc. Nursing / GNM / ANM)
- No Objection Certificate issued by the concerned State Nursing Council
- Passport-size photograph:
 - One copy affixed in the application form (duly attested by Principal/PNO)
 - Four additional copies (unattested), standard size (3 × 4 cm)
- H.S.L.C. Admit Card
- Residential Address Proof (Govt. ID / Ration Card / Voter Card / Passport)
- PAN Card

- Applications without the above documents will be summarily rejected.
- All documents are subject to strict verification and authentication.
- The Council reserves the right to seek additional clarification or verification from the concerned institutions/authorities.
- Any submission of false or fabricated documents will lead to rejection of application and legal action as per rules.

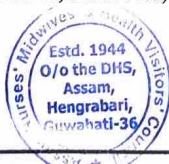
